Scope of Work

- 1- The vendor is responsible to provide, daily six metric tons capacity trucks with drivers and labors as requested/directed by the Blumont team.
- 2- The six metric tons trucks and the laborers will be used moving/transporting goods/items related to distribution activities within and between both camps (Al Hol & Roj) as directed by Blumont team, as per below breakdown:
Al Hol: 17 six metric ton capacity trucks with a driver and 51 labors (3 labors per each truck) as requested/directed by the Blumont team.
Roj: 3 six metric ton capacity trucks with a driver and nine labors (3 per each truck) as requested/directed by the Blumont team.
- 3- The Blumont team shall request numbers and camps/places where the required six metric tons capacity trucks with drivers and laborers shall work, 1 day in advance, using a request form that has been designed for this purpose by Blumont.
- 4- The vendor must strictly adhere to the Blumont six metric tons capacity trucks with drivers’ and labors requests, in terms of number of each with a driver/labors and date/time of provision and locations.
- 5- The vendor must assign a Representative at each camp to deal with the Blumont teams and provide adequate staff, laborers, and trucks with drivers, affiliates, personnel and/or agents to undertake the daily tasks and as directed by the Blumont team.
- 6- The vendor must take care of all local authorities’ letters, permits, memos and approvals whatsoever. Blumont shall undertake no responsibility at all to secure any kind of local authorities’ approvals and/or permits.
- 7- When providing daily six metric tons capacity trucks with drivers and laborers, the vendor must strictly adhere to the Local Authorities laws, rules and regulations, including but not limited to security guidelines.
- 8- The vendor shall be solely responsible for the security and safety of his staff members, laborers, and six metric tons capacity trucks with drivers, affiliates, personnel and/or agents. To this effect, he is responsible to strictly adhere to the Syrian labor safety regulations and requirements.
- 9- The vendor shall be solely liable in case of any kind of diseases, damages, injuries and/or death that may occur to his staff members, laborers, six metric tons capacity trucks with drivers, affiliates, personnel and/or agents, as direct and/or indirect result of implementation of this contract.
- 10- The vendor shall be solely liable in case of any kind of diseases, damages, injuries and/or death that may occur to any third party, as direct and/or indirect result of implementation of this contract.
- 11- Blumont shall settle the vendor’s accounts at the end of each month after at least 10 days of receiving a proper invoice and all adequate payable financial papers.

Scope of Work

a wire transfer to his own bank. In case the vendor does not maintain a bank account within the Kurdistan Region of Iraq’s territories, then the vendor’s entitlements shall be paid through cash transfer to Syria, as advised by the vendor.

13- The vendor must deposit an amount that is equivalent to 10% of this contract’s value. In case the vendor unjustifiably seizes the work or decides to early terminate this contract, then Blumont shall keep the deposited amount as compensation of the damages Blumont may suffer in result of the vendor’s action.

14- In case the vendor is late in his performance, then Blumont has the right to impose a penalty that is equivalent to 1% of the total contract value for each 1 day of delay.

15- The vendor must provide all machine drivers and laborers with an adequate work uniform, a hat, gloves, boot, masks and a safety vest.

16- The vendor shall provide First Aid Kits at the workplace to use once an incident takes place.

17- The truck drivers must have valid Syrian driving license/local authority license.

18- The truck must be fully functional and must be in usable conditions as required by valid relevant Syrian laws.

19- The vendor must not employ minors as workers, all workers must be within the legal age according to the Syrian Labor Law.

NOTE:

1. Our organization has the right to reject any above mentioned items when delivered by the contractor in case if the quality of the item is not meet our spesifications and required quality and to request a better quality.

2. Our organization is not bound to buy the whole quantity mentioned in the Financial Offer.

3. Our organization is not bound to contract with one company and can split the award between one or more companies.

4. The Service must delivered to Al-Hol and Roj Camps as per the instruction of Our Organization's Supervisor .

5. The offered Price includes, transportation, loading & unloading and any other cost to deliver service to Al-Hol and Roj Camps.
