**SCOPE OF WORK:**

- 1.The contractor is responsible to providing, transporting, delivery, storage and timely and adequately distributing high quality of diesel as directed by the Blumont team.
- 2.The contractor is responsible for the security of his diesel points and diesel storage tanks. This should be done through coordination with the Camp Administration.
- 3.The contractor is responsible for the crowd control at the diesel distribution points.
- 4.The Blumont team shall request quantities and destinations of the required diesel for distribution 4-6 days in advance, using a request form that has been designed for this purpose by Blumont.
- 5.The contractor must strictly adhere to the Blumont diesel supply requests, in terms of date/time of supply, quantities and destinations.
- 6.The contractor must assign a Representative at each camp to deal with the Blumont teams and provide adequate number of staff, laborers, affiliates, personnel and/or agents to undertake diesel distribution, transportation, delivery, storage, and security processes as directed by the Blumont team.
- 7.The contractor must adjust the diesel tanker outlets as directed by the Blumont team, so as to expedite the diesel distribution pace.
- 8.The contractor must take care of all local authorities' letters, permits, memos and approvals whatsoever. Blumont shall undertake no responsibility at all to secure any kind of local authorities' approvals and/or permits.
- 9.The contractor shall be solely responsible for the security and safety of his staff members, laborers, affiliates, personnel and/or agents. To this effect, he is responsible to strictly adhere to the Syrian labor safety regulations and requirements.
- 10.The contractor shall be solely liable in case of any kind of diseases, damages, security incidents, injuries and/or death that may occur to his staff members, laborers, affiliates, personnel and/or agents, as result of implementation of this contract.
- 11.Blumont shall only pay the contractor for the quantities of diesel which have been accepted by Blumont and provided and distributed by the contractor in an adequate manner and timely fashion.
- 12.The contractor is responsible to provide and secure at least 2 fire engine 12Kg to be based in the camp during the diesel distribution and storage period, this fire engine must stay on standby for any fire incidents that may occur in the diesel distribution and storage points.
- 13.The contractor is responsible to provide all his staff members, laborers, affiliates, personnel and/or agents with safety tools during the storage and distribution processes.
- 14.The contractor is responsible to train all his staff members, laborers, affiliates, personnel and/or agents on the Civil Defense courses, using fire extinguishers, and how to deal with fire incidents.
- 15.The contractor is responsible to provide electric source "Generator not less than 10 Kva " to operate flow meters, this need if there no power available at Dist sites.
- 16.The Contractor must ensure transfer and storing diesel in suitable Tankers "designed for fuel & diesel ". Also contractor shall provide flow meter with each tanker.
- 17.Contractor is responsible to provide fixed Tankers per each site according to Blumont field team advise and needs per each round.

**NOTES:**

- 1- In case if the quality of the diesel dose not meet our spesifications and required quality, Our organization has the right to reject the diesel and request a better quality.
- 2- Our organization is not bound to buy the whole quantity mentioned in the Financial Offer and will order as per need.
- 3- All the item quantities should be apply INCOTERM 2010 DDP (Delivery Duty Paid) to the mentioned locations.
- 4- Our organization is not bound to contract with one company and can split the award between one or more companies.
- 5- The delivery Locations are Washokani and Sarekanye Camps in North-East Syria
- 6- The offered Prices includes, transportation, loading & unloading, distributing and any other cost to deliver and Implementation to locations mentioned in point(5) above in North East SYRIA.
- 7- All distribution should be carried out by the contractor and our staff will just monitor the distribution process.
